I, Simon B. Paris, declare and state as follows:

- 1. I am a Partner of the law firm of Saltz, Mongeluzzi, Barrett & Bendesky, PC. I submit this declaration in support of Direct Purchaser Plaintiffs ("DPP") application for an award of attorneys' fees and reimbursement of expenses in connection with the services rendered in this litigation. I make this Declaration based on my own personal knowledge, and if called as a witness, I could and would competently testify to the matters stated herein.
- 2. My firm has served as counsel to Univision-Crimson Holding, Inc. and as counsel for the Direct Purchaser Class ("Class") throughout the course of this litigation. The background and experience of Saltz, Mongeluzzi, Barrett & Bendesky, PC and its attorneys are summarized in the *curriculum vitae* attached hereto as Exhibit 1.
- 3. Saltz, Mongeluzzi, Barrett & Bendesky, PC has prosecuted this litigation solely on a contingent-fee basis, and has been at risk that it would not receive any compensation for prosecuting claims against the Defendants. While Saltz, Mongeluzzi, Barrett & Bendesky, PC devoted its time and resources to this matter, it has foregone other legal work for which it could have been compensated.
- 4. During the pendency of the litigation, Saltz, Mongeluzzi, Barrett & Bendesky, PC performed the following work: researched and drafted opposition to pleading challenges raised by Defendants, and reviewed documents produced by Defendants.
- 5. Attached hereto as Exhibit 2 is my firm's total hours and lodestar, computed at historical rates, for the period of June 1, 2013 through August 31, 2017. This period reflects the time spent after the appointment of Interim Co-Lead Counsel and Liaison Counsel for Direct Purchased Plaintiffs ("DPP") in this litigation. The total number of hours spent by Saltz, Mongeluzzi, Barrett & Bendesky, PC during this period of time was 6,030.50, with a corresponding lodestar of \$2,333,189.50. My firm's lodestar figures are based on the firm's historical billing rates which do not include charges for expense items. Expense items are billed separately and such charges are not duplicated in my firm's billing rates. This summary was prepared from contemporaneous, daily time records regularly prepared and maintained by my

firm. The lodestar amount reflected in Exhibit 2 is for work assigned by DPP Co-Lead Counsel, and was performed by professionals at my law firm for the benefit of the Class.


- 6. Saltz, Mongeluzzi, Barrett & Bendesky, PC has reviewed the time and expense records that form the basis of this declaration to correct any billing errors. In addition, my firm has removed all time entries and expenses related to the following:
- a. time spent reading or reviewing pleadings, ECF notices or other papers unless a necessary part of perfoming a specific assignment from Co-Lead Counsel;
- b. travel time unless the attorney or professional was actively engaged in preparation or work in connection with a particular assignment made by Co-Lead Counsel which necessitated travel;
- c. billing for time connected with creating timekeeping records or for the time of attorneys or staff expended in preparation of audited time records and expenses in support of DPPs' application for an award of attorneys' fees and reimbursement of expenses.
- 7. The hourly rates for the attorneys and professional support staff in my firm included in Exhibit 2 are the same as the regular rates charged for their services in non-contingent matters and/or which have been accepted in other complex or class action litigation subject to the hourly rate caps established by DPP Co-Lead Counsel, including:
- a. the highest hourly rates for Attorneys at the highest Partner level is capped at \$850 per hour;
- b. the highest hourly rates for Attorneys at the Of-counsel/Special counsel level for substantive work is capped at \$650 per hour, which excludes document review;
- c. the highest hourly rates for Attorneys at the highest Associate level for substantive work is capped at \$450 per hour, which excludes document review;
- d. the highest hourly rates for Attorneys at the Associate level engaged in English-language document review is capped at \$350 per hour; a cap of \$400 per hour is permitted where the reviewer has special skill set, such as foreign language translation, and Lead Counsel has approved that work performed; and

- e. the highest hourly rates for Paralegals and investigators is capped at \$175 per hour.
- 8. My firm has expended a total of \$850.12 in unreimbursed costs and expenses in connection with the prosecution of this litigation. These costs and expenses are broken down in the chart attached hereto as Exhibit 3. They were incurred on behalf of Direct Purchaser Plaintiffs by my firm on a contingent basis, and have not been reimbursed. The expenses incurred in this action are reflected on the books and records of my firm. These books and records are prepared from expense vouchers, check records and other source materials and represent an accurate recordation of the expenses incurred.
- 9. Saltz, Mongeluzzi, Barrett & Bendesky, PC also paid a total of \$65,000.00 in assessments for the joint prosecution of the litigation against the Defendants.
- 10. My firm has carefully reviewed the time and expenses that comprise its reported lodestar and out of pocket expenses and represents that such lodestar and expenses comply with all material applicable terms of the May 21, 2013 letter from Co-Lead Counsel regarding Protocols for Maintaining and Reporting Time and Expense as well as Modified Pretrial Order No. 1 with Exhibit A (Dkt. No. 202, May 24, 2013).

Stephen Saltz Founder

1941-2006

Stephen T. Saltz, the gifted lawyer-mentor and co-founder of Saltz Mongeluzzi Barrett & Bendesky, PC, a leading Philadelphia plaintiff litigation firm, died Tuesday, September 6, after a long illness. Not surprisingly to those familiar with Mr. Saltz and his passion for advocacy, he continued to work and battle on behalf of his clients during much of his own bout with cancer.

Mr. Saltz, born November 11, 1941, was a skilled litigator whose courtroom tenacity was in marked contrast to his typically easy-going manner, became a co-founder of the Firm following a distinguished public sector career that

included representing indigent clients as a criminal defense attorney with the Philadelphia Defenders Association and later as a Deputy City Solicitor and then Solicitor in Charge of the Philadelphia Office of Civil Rights Office Litigation.

During his nearly 40-year legal career, the former president of the Philadelphia Trial Lawyers Association developed a renowned reputation within the Philadelphia legal community as a relentless fighter for his clients – winning many landmark personal injury and civil rights cases -- while always following the highest ethical standards of legal practice. In so many ways, he was regarded among his peers as "the lawyer's lawyer". Mr. Saltz was selected by his colleagues as one of Pennsylvania's "Super Lawyers" every year since the list was first published in 2004.

"As part of his extended family, we mourn Steve's passing along with his loved ones and celebrate his extraordinary accomplishments during his brilliant legal career in which he positively influenced the lives of so many, especially those who were the victims of injustice," said Michael Barrett of the Firm. It is so rare in any profession to find someone who is universally liked and respected, but that was Steve. He set the bar very high and challenged us all to raise it even higher."

He faced his illness with the same drive and determination he handled the most difficult legal cases. He trained for and rode in the 2005 American Cancer Society 62-mile Bikeathon, serving as co-chair of the Philadelphia Bar Association Bikeathon team.

A 1967 graduate of the Villanova University School of Law, Mr. Saltz held an undergraduate degree from the University of Miami. He chaired the Pennsylvania Supreme Court Disciplinary System between 1994 and 1996 following four years as a hearing examiner for the system. He also was a judge pro tem of the Philadelphia Court of Common Pleas since 1991 and served as a federal mediator for the U.S. District Court between 1992 and 2003.

He was also a member of the boards of governors of the Philadelphia Bar Association (1987-89) and the Philadelphia Trial Lawyers Association (1992) and a seven-year member of the Temple American Inn of Court. He chaired several Bar committees.

Mr. Saltz is survived by his wife, Rowena, of 36 years.

Employment Class Actions

The federal securities laws were designed to promote a level playing field for investors by requiring full and fair disclosure of all material facts about public companies. When a company seeks to inflate the price of its shares by making false or misleading statements to analysts, brokers or investors, or by using improper accounting practices, federal securities fraud claims may lie. Securities laws have been particularly relevant to Taft-Hartley pension and retirement funds since passage of the Private Securities Litigation Reform Act of 1995, which specifically encouraged institutional investors to protect the assets held for their beneficiaries and other investors by serving as lead plaintiffs in securities class actions.

Shareholder Derivative Actions

Derivative actions are lawsuits brought by shareholders against a company's officers or directors that generally allege a breach of fiduciary duties. Derivative claims can be appropriate where, for example, a company's officers or directors have been engaged in self-dealing or where a company has sold assets to an officer or director for less than fair market value. These are cases that companies should bring but do not, usually because its officers or directors exercise improper influence over the company's affairs. If a derivative action is favorably resolved, the individuals found to have harmed

the company may be required to make monetary payments to the company. Successful derivative actions may also lead to corporate governance changes, so that the conduct complained of will not happen again. Derivative suits will generally benefit shareholders through improved corporate governance and gains in share price.
